4. **FEE SCHEDULE**

Note: This meeting was a continuation to the Budget Committee meeting held on March 7, 2018 where changes to the Fee Schedule was discussed. The Community Development Department was the only Department that did not get a chance to mention their Recommended changes.

Linda Portal explained the fee schedule as it related to the Community Development Department. Linda indicated that the title of this department may change to Development Services to better reflect the services that the department provides. Linda indicated that the only fee now being charged relating to her department was \$300.00 for site plan review. She explained that there are now fees contained in the

Fee Schedule for staff time for planning services. She went into detail on a new tracking system based upon the size of the project (etc. major or minor). Increased Fees were included for: Special Magistrate Hearings (I.e. Zoning variances from \$350 to \$450.00; Alcoholic Beverage Permit from \$300 to \$500; Under Land Use Amendment from \$1,500 to \$2,000; and Rezoning from \$1,000 to \$1,500.00 to mention a few.
